AMENDED COMPANY BY-LAWS AND SHARE CAPITAL VARIATION OF AQUAFIL S.P.A. FOLLOWING THE EXERCISE OF THE MARKET WARRANT HAS BEEN PUBLISHED

Arco (TN), July 5, 2018 – Aquafil S.p.A. [ECNL IM] informs that the Company By-laws, in the version filed with the Companies' Register of Trento on June 1, 2018 and inscribed on July 5, 2018, updated following the exercise of the Market Warrant of Aquafil S.p.A. in May 2018, is available at the registered offices, on the website of the Company (www.aquafil.com – Corporate Governance section), as well as on the authorised storage system eMarket STORAGE at www.emarketstorage.com.

Resulting from the Exercise Period of *Market Warrant* Aquafil S.p.A. (*Warrant*) relating to May 2018, the new composition of the equity share capital is as follows:
