REPORT - BUY BACK PROGRAM

Milan, 23 July 2018 – Openjobmetis S.p.A. – Agenzia per il lavoro communicates the transactions on own shares for the period between 16 July 2018 and 20 July 2018 within the limits resolved by the shareholders' meeting on 24 April 2018 (as already communicated to the market with the press releases on 24 April 2018 and 15 May 2018). As a consequence of the transactions carried out within the buy back program, Openjobmetis holds a total of 222,071 own shares equal to approximately 1,6195% of its share capital.

In December 2015, CRIBIS D&B awarded the CRIBIS D&B Rating 1 to Openjobmetis, recognising the company at the highest level of economic and financial reliability, in 2017 and 2018 it further upgraded the rating, awarding it the title of CRIBIS Prime Company, which bears witness to the high level of creditworthiness and economic and financial solidity.
