UPDATE ON WESTERNLINK CABLE PROJECT

Milan, 12 September 2018. Prysmian Group informs that the commissioning and testing of the cable connecting Scotland and Wales (the *WesternLink Interconnection*) has been temporarily interrupted due to the need to investigate problem which occurred in the onshore section of the cable.

Although preliminary technical investigations necessary to identify the cause of the problem and to estimate its possible financial effects are still ongoing and will take a few days to be completed, Prysmian can confirm that this event appears unrelated to the fault which was detected in June 2018 in the submarine section of the WesternLink Interconnection, which was successfully repaired.

Prysmian remains committed to solve the issue in the shortest time possible, with the lowest environmental and logistic impact, and will provide further updates as soon as the technical assessment of the event is completed.
