## AQUAFIL S.P.A. MARKET WARRANT EXERCISE CONVERSIONS OCCURRED IN SEPTEMBER 2018

**Arco (TN), October 2, 2018** - Aquafil S.p.A. (*Aquafil* or the *Company*) [ECNL IM] informs that, pursuant to the Aquafil S.p.A. Market Warrants Regulation, at the conclusion of the exercise period of *Market Warrant* Aquafil S.p.A. (*Warrant*), relating to September 2018, n. 8,125 Warrant have been exercised, corresponding to n. 1,954 Aquafil ordinary shares, for a total consideration of €195.40.

On conclusion of the exercise period, the total number of Aquafil outstanding shares increased from 51,141,992 to the current 51,143,946. In particular, ordinary shares increased from 42,745,972 to 42,747,926. The number of Class B and C shares remains unchanged.
