## UPDATE ON THE SHARE BUY-BACK PROGRAM

---

Milan, November 12<sup>th</sup>, 2018 - In relation to the share buy-back program resolved by the Shareholders' Meeting of April 20<sup>th</sup>, 2018, Amplifon (MTA; Bloomberg ticker: AMP:IM), the global leader in hearing solutions and services, announces that it has purchased in the period 5<sup>th</sup> - 9<sup>th</sup>, 2018, a total of 25,000 ordinary Amplifon S.p.A. shares, equivalent to 0.011% of the share capital, at an average unit price of Euro 15.676 per share, for a total consideration of Euro 391,893.00.

On the basis of information provided by the intermediary agent appointed for the implementation of the share buy-back program, here below the details of the share purchase transactions on the MTA on daily basis:

In reference to the same resolution, the Company has used treasury shares to service the Performance Stock Grant Plan 2011-2020 for a total of n. 8,544,922 shares.

As of November 9<sup>th</sup>, 2018, Amplifon owned n. 5,696,073 of its shares, corresponding to 2.517% of the Company's share capital and to 1.733% of the total share capital in voting rights.
