## Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 5 May 2015, 28 April 2016, 27 April 2017 and 8 May 2018, and launched on 14 September 2015, Sabaf S.p.A. informs that in the period between 12 November 2018 and 16 November 2018 acquired no. 1,690 treasury shares at an average unit price of € 14.4616 per share, for a total amount of € 24,440.10.
