## REPORT - BUY BACK PROGRAM

**Milan, 3 December 2018** – Openjobmetis S.p.A. – Agenzia per il lavoro communicates the transactions on own shares for the period between 26 November 2018 and 30 November 2018 within the limits resolved by the shareholders’ meeting on 24 April 2018 (as already communicated to the market with the press releases on 24 April 2018 and 15 May 2018). As a consequence of the transactions carried out within the buy back program, Openjobmetis holds a total of 367,154 own shares equal to approximately 2.6776% of its share capital.

In 2018 Openjobmetis acquired 100% of Coverclip Srl, now Meritocracy Srl, the Italian digital platform for personal research, with the goal of embedding and developing Artificial Intelligence in the current job search and matching activities. In the same year acquired 70% of HC Human Connections Srl an educational company that carries out interventions dedicated to the development and coaching of Human Resources in organizations.
