**OPENJOBMETIS TAKES PART IN THE EUROPEAN MIDCAP EVENT OF GENÈVE**

*Milan, 3 December 2018* - Tomorrow, Openjobmetis S.p.A. (Borsa Italiana: OJM), one of the leading Employment Agencies, listed on the Italian Stock Market - STAR segment, will take part in the European Midcap Event in Genève, an event organized by Intermonete SIM that allows Italian listed companies to meet, in one2one, important European institutional funds.

The event will be attended by the CEO, Rosario Rasizza and the CFO, Alessandro Esposti.

During the meetings, the Top Management of Openjobmetis will present the results obtained in the first nine months of the year, growing in the main economic and financial indices. Revenues reached € 443.6 million (+ 3.3% compared to the same period of 2017), the increase in research and selection revenues confirmed at + 57%, the first margin increased from 12.3% to 12.5%, and the net financial position has clearly improved.

**Openjobmetis at a glance:** Openjobmetis SpA is a private employment agency created in 2011 through the merger of Openjob SpA and Metis SpA, which have pooled together the know-how and unique expertise that has distinguished them for over 17 years. Since December 2015, Openjobmetis is the first and only private employment agency listed on the Italian Stock Exchange, in the STAR segment and is one of the leading Italian operators in its field, with revenues of approximately €584 million in the year ended 31 December 2017.

In 2018 Openjobmetis acquired 100% of Coverclip Srl, now Meritocracy Srl, the Italian digital platform for personal research, with the goal of embedding and developing Artificial Intelligence in the current job search and matching activities. In the same year acquired 70% of HC Human Connections Srl an educational company that carries out interventions dedicated to the development and coaching of Human Resources in organizations.
