**Arco (TN), December 3, 2018** – Aquafil S.p.A. [ECNL IM] announces that, pursuant to Article 3.6 of the Rules for the “Market Warrant Aquafil S.p.A.” Warrants, the arithmetic average of the weighted average price of all ordinary Aquafil shares (ISIN IT0005241192) traded on the MTA market on a daily basis in November 2018 (as announced by the calculation agent BNP PARIBAS Securities Services) is € 9.5789.

Accordingly, the exercise ratio for the conversion of the *Market Warrant* Aquafil S.p.A. warrants for December 2018 is 0.00832375064.
