Assago, 06 December 2018 – Italiaonline S.p.A., a company listed in the MTA of Borsa Italiana, leader on the Italian digital market, announces the purchase, in the period from 29 November 2018 to 05 December 2018, of no. 3,749 ordinary shares at an average unit price of Euro 2.3510 for a total amount of Euro 8,814.00, as specified in the table below. The purchases were made within the authorization to the treasury shares purchase plan approved by the Shareholders' Meeting on 27 April 2018. The start of the purchase plan was announced to the market on 28 November 2018, pursuant to art. 144-bis of Consob Regulation 11971/1999.

On the basis of information provided by the intermediary agent appointed for the implementation of the share buy back plan, below are the details of the purchases of treasury shares (Italiaonline ordinary shares ISIN code IT0005187940) on the MTA (Electronic Stock Market), on a daily basis in the reference period:
