ASSEMBLEA STRAORDINARIA E ORDINARIA DEGLI AZIONISTI

Genova, 22 dicembre 2018 – Si è tenuta oggi l'Assemblea straordinaria degli azionisti di Banca Carige che ha approvato i seguenti punti all'ordine del giorno:

- riduzione del capitale sociale per perdite, ai sensi dell'articolo 2446 C.C.;
- non ricostituzione delle riserve valutative.

L'Assemblea straordinaria non ha approvato i seguenti punti all'ordine del giorno:

- attribuzione al Consiglio di Amministrazione della delega, anche ai sensi dell'art. 2443 del Codice Civile, per aumentare a pagamento il capitale sociale per un importo massimo complessivo, comprensivo di eventuale sovrapprezzo, pari a €400.000.000,00;
- raggruppamento delle azioni ordinarie e di risparmio in circolazione nel rapporto di n. 1 (una) nuova azione ogni n. 1.000 (mille) esistenti;

- conversione facoltativa delle azioni di risparmio della Banca in azioni ordinarie secondo un rapporto di conversione pari a n. 20.500 (ventimilacinquecento) azioni ordinarie per ogni azione di risparmio.

Infine l'Assemblea, in sede ordinaria, ha integrato, in conformità a quanto previsto dalla vigente normativa e dallo Statuto, il Collegio Sindacale, nominando Luca Sintoni quale Sindaco Effettivo e Presidente del Collegio Sindacale e Fabio Monti quale Sindaco supplente. I Sindaci così nominati scadranno dalla carica unitamente agli altri membri del Collegio Sindacale, in occasione dell'Assemblea che verrà convocata per l'approvazione del bilancio al 31 dicembre 2019; il curriculum vitae dei neominati Sindaci comprovanti le caratteristiche di professionalità, onorabilità ed indipendenza, vengono messi a disposizione del pubblico sul sito internet del Gruppo www.gruppocarige.it. A seguito di tale nomina, Fiorenza Dalla Rizza torna a ricoprire l'incarico di Sindaco Supplente.
