*Florence, January 8, 2019* – With reference to the plan for purchasing its own ordinary shares passed by the Shareholders' Meeting held in ordinary session on April 20, 2018, whose launch has been also resolved by the Board of Directors held on May 7, 2018, as communicated to the market on the same date according to article 144-*bis* of the of the Consob Regulation adopted with resolution no. 11971/1999, Salvatore Ferragamo S.p.A. (MTA: SFER), parent company of the Salvatore Ferragamo Group, announces that it has purchased on the MTA – Italian Equities Market organized and managed by Italian Stock Exchange Borsa Italiana S.p.A. in the period from December 27, 2018 to January 2, 2019 nr. 50.000 Salvatore Ferragamo S.p.A.'s ordinary shares (ISIN code: IT0004712375), equal to 0,03% of the share capital, at an average unit price of Euro 17,7537 per share, for a total countervalue equal to Euro 887.685,00.
