## ACQUISTO DI AZIONI PROPRIE A SERVIZIO DEI PIANI DI COMPENSI BASATI SU STRUMENTI FINANZIARI APPROVATI DA UNIPOLSAI E DA ALCUNE SOCIETA' CONTROLLATE

Bologna, 21 marzo 2019

Con riferimento al comunicato stampa del 15 marzo 2019 avente ad oggetto, tra l'altro, l'avvio, il giorno 15 marzo 2019, dei programmi di acquisto (i "Programmi") di azioni proprie (le "Azioni") di UnipolSai Assicurazioni S.p.A. ("UnipolSai") da parte di UnipolSai medesima e delle seguenti società dalla stessa direttamente controllate: Alfaevolution Technology S.p.A. ("Alfaevolution"), Gruppo Una S.p.A. ("Gruppo Una"), Leithà S.r.l. ("Leithà"), SIAT S.p.A. ("Siat"), UnipolSai Servizi Consortili S.c.r.l. ("USSC") e UniSalute S.p.A. ("UniSalute" e, unitamente alle altre società controllate, le "Controllate"), a servizio dei Piani di compensi basati su strumenti finanziari, del tipo *performance share*, destinati al personale Dirigente di UnipolSai e delle Controllate per il triennio 2016-2018, si rende noto quanto segue.

Ai sensi e per gli effetti dell'art. 5, terzo comma, del Regolamento (UE) 596/2014 e dell'art. 2, terzo comma, del Regolamento delegato (UE) 2016/1052, sono state acquistate sul mercato regolamentato, i giorni 15 e 18 marzo 2019, un totale di n. 1.344.000 Azioni (pari a circa lo 0,047% del capitale sociale di UnipolSai) per complessivi Euro 3.112.828,99 e precisamente:

- UnipolSai ha acquistato n. 1.200.000 Azioni, per un corrispettivo complessivo di Euro 2.782.331,85 (corrispettivo medio Euro 2,3186);
- le Controllate hanno acquistato n. 144.000 Azioni, per un corrispettivo complessivo di Euro 330.497,14.

Ai sensi delle sopra richiamate disposizioni normative, si allegano – per UnipolSai e per ciascuna Controllata – gli elenchi di dettaglio delle singole operazioni di acquisto effettuate con l'indicazione delle quantità, dei rispettivi prezzi e orari di esecuzione.

Si precisa inoltre che, attraverso le descritte operazioni, UnipolSai e le Controllate hanno concluso i rispettivi Programmi di acquisto di azioni proprie.

Alla data odierna UnipolSai detiene complessivamente n. 51.396.345 azioni proprie ordinarie (pari a circa l'1,816% del capitale sociale), di cui n. 48.396.345 indirettamente tramite le società controllate Alfaevolution (n. 8.000), Arca Vita S.p.A. (n. 10.000), Gruppo Una (n. 46.000), Leithà (n. 3.500), Pronto Assistance S.p.A. (n. 344.312), SIAT (n. 37.000), UnipolSai Finance S.p.A. (n. 38.454.775), UnipolSai Nederland B.V. (n. 9.443.258), Unisalute (n. 18.500) e USSC (n. 31.000).
