[ECNL IM] announces that on today's date the Notice of Calling of the Ordinary Shareholders' Meeting to be held on April 23, 2019 and the Board of Directors' Illustrative Reports on the Agenda items, as well as the Shareholders' Meeting proxy form and Certificate of the proxy holder in case of delivery or transmission of copy of the proxy, have been published.

The financial statements and/or financial schemes of Aquafil S.p.A.'s subsidiaries and associates pursuant to Article 2429, paragraphs 3 and 4, or the Italian Civil Code, as well as the accounting statements of the non-EU significant subsidiaries — prepared pursuant to Article 15 of Consob Rules for Markets No. 20249/ 2017 — will be made available to the public in the manner and within the terms provided for by applicable regulations in force.

In addition, the Notice of Calling was also published today, in excerpt form, on the Italian daily newspaper Il Sole 24 Ore.
