### DISCLOSURE PURCHASE TREASURY SHARES

*Assago, 25 March 2019* – Italiaonline S.p.A., a company listed in the MTA of Borsa Italiana, leader on the Italian digital market, announces the purchase, in the period from 18 March 2019 to 22 March 2019, of no. 5,471 ordinary shares at an average unit price of Euro 2.3076 for a total amount of Euro 12,624.64, as specified in the table below. The purchases were made within the authorization to the treasury shares purchase plan approved by the Shareholders' Meeting on 27 April 2018. The start of the purchase plan was announced to the market on 28 November 2018, pursuant to art. 144-bis of Consob Regulation 11971/1999.

On the basis of information provided by the intermediary agent appointed for the implementation of the share buy back plan, below are the details of the purchases of treasury shares (Italiaonline ordinary shares ISIN code IT0005187940) on the MTA (Electronic Stock Market), on a daily basis in the reference period:
