### SERVIZI ITALIA: NOTIFICATION OF SHARE BUY BACK

Servizi Italia S.p.A. informs that, in the period between 25 March 2019 and 29 March 2019 the Company bought on the Milan Stock Exchange, pursuant to the resolution passed at the Shareholder's Meeting held on 20th April 2018 (previously communicated as per Art. 144 bis of Consob regulation 11971/1999), n. 6,900 ordinary shares (corresponding to 0.022% of the Company's share capital) at an average price of Euro 3.963 per share, for a total of Euro 27,341.70.
