Milan, April 2nd 2019 – WIIT S.p.A. The WIIT stock will have the same ISIN code (0004922826) as attributed at the time of admission to trading on AIM Italia.

Alessandro Cozzi, CEO, commented: “Borsa Italiana has today initiated the trading of **WIIT** shares on the **STAR segment** of the **MTA Italian Stock Exchange**. This marks the conclusion of a journey starting firstly with the Elite project, and subsequently with listing on the AIM Italia market in June 2017. We had already announced the goal of transferring in a short timeframe to the main market and to drive growth further both organically and through acquisitions. We are therefore very proud of this achievement, which for us represents only the beginning of a long path. We are confident that the STAR segment - which represents the very best of Italian enterprise - will provide our company with real visibility to Italian and overseas investors in the future, while today we are ready to tackle this challenge”.
