DIVIDEND PAYMENT

The shareholders are advised that, pursuant the resolution taken during the General Meeting on April 24th, 2019, starting from May 15th, 2019 (detachment date May 13th, 2019 and record date May 14th 2019) a dividend of 0.01 € per ordinary share (coupon n. 35) will be paid, before deductions as provided by law.

The shareholders may collect the dividend from their respective intermediaries. In case of sharers not yet dematerialized, the shareholders must previously deliver them to an authorized intermediary in order to register them in an centralized management system, in dematerialized form.
