# PURCHASE OF TREASURY SHARES OF ITALIAONLINE CONTINUES

*Assago (MI), May 13, 2019* – Italiaonline S.p.A., a company listed on the MTA of Borsa Italiana, leader in the Italian digital market, hereby announces that, following the authorization to purchase and dispose Company's treasury shares granted by the Ordinary Shareholders' Meeting on April 30, 2019, upon revocation, for the portion that has not been implemented, of the authorization granted by the Ordinary Shareholders' Meeting on April 27, 2018 (as communicated to the market on the same date), continues the purchase of treasury shares pursuant to the above authorization, through the same intermediary appointed for the previous purchases of treasury shares.

The intermediary purchases the treasury shares of Italiaonline S.p.A. in full independence, in compliance with the limits of applicable laws and of the above authorization.

Purchases of treasury shares are carried out on the MTA pursuant to article 144-bis, paragraph 1, of Consob Regulation no. 11971/1999. In particular, purchases of treasury shares are carried out in compliance with the procedures established by Borsa Italiana S.p.A. which does not allow the direct combination of offers to buy with pre-determined offers to sell and, in any case, in compliance with Consob's accepted market practices applicable from time to time pursuant to article 180, paragraph 1, letter c, of Legislative Decree No. 58/1998 and with the other laws and regulations applicable to these transactions.

The Company, during the period of the authorization granted by the Ordinary Shareholders' Meeting on April 27, 2018, has purchased, in aggregate, no. 52.592 ordinary treasury shares, equal to 0.046% of the share capital.
