Appointment of the Board of Directors

The ordinary Shareholders' Meeting of Tiscali, after determining the number of members of the Board of Directors at 7, has appointed the new Board of Directors.

The Shareholders' Meeting resolved that the Directors of the Company will remain in office until the approval of the financial statements for the year that will close at 12/31/2021.

The new Board of Directors, with a female majority, appointed on the basis of the single list presented jointly by the shareholders Renato Soru and Amsicora srl (jointly holding a 29.9% stake in the share capital), which obtained 99.99% of the votes of those attending the meeting, consists of:

It should be noted that the Directors Alberto Trondoli and Manilo Marocco hold an indirect stake in Tiscali S.p.A. through Amsicora Srl, which holds 22.0627% of the Company's share capital, and that the Director Renato Soru holds a direct and indirect stake in Tiscali S.p.A. for a total of 7.9372% of the aforementioned capital.
