INFORMATION RELATED TO THE IMPLEMENTATION OF THE SHARE BUY-BACK PROGRAMME (PERIOD 15TH JULY – 19TH JULY 2019)

Biadene di Montebelluna, July 22, 2019 – Geox S.p.A. (“**Geox**”), under the share buy - back programme announced to the market on June 4, 2019 to buy back up to a maximum of 3,996,250 ordinary shares (equal to 1.54% of the current share capital) servicing 2019-2021 Stock Grant Plan – according to the provisions of the (EU) Regulation no. 596/2014 and the (EU) Delegated Regulation no. 1052/2016 - hereby announces to have acquired (in the period from 15th July 2019 to 19th July 2019) 170,767 ordinary shares (corresponding to 0.07% of the total number of ordinary shares) at a weighted average price of Euro 1.3561 for a total counter-value of Euro 231,569.06.
