NOTIFICATION OF CHANGES IN THE TOTAL AMOUNT OF THE VOTING RIGHTS

(Article 85-bis, section 4-bis, of Consob Regulation no. 11971/1999)

Milano, 6 September 2019 – WIIT S.p.A. (“**WIIT**” or the “**Company**”), a leading Italian player in the Cloud Computing market of enterprises demanding uninterrupted Hybrid Cloud and Hosted Private Cloud services for critical applications, hereby announces that from today become effective the increase of voting rights - pursuant to article 127-*quinquies* of Legislative Decree 58/1998 (“**Decree 58/98**”) and in application of the provisions set out in the Company's by-laws - relating to 1,621,646 WIIT ordinary shares, owned by WIIT FIN S.r.l.

In particular:

- WIIT's share capital is equal to EUR 2,652,066 and consists of 2,652,066 shares; and
- At the date hereof, the increased voting right accrued for 1,621,646 shares (two voting rights per share) out of a total of 2,652,066 shares, which resulted in a change of total voting rights from 2,652,066 to 4,273,712.
