### **ASSEMBLEA STRAORDINARIA DEGLI AZIONISTI CARIGE DEL 20 SETTEMBRE 2019: OLTRE 10 MILA I BIGLIETTI DI PARTECIPAZIONE GIÀ RICHIESTI**
