CFT S.P.A. COMPLETES FULL ACQUISITION OF ROLEC PROZESS- UND BRAUTECHNIK GMBH

Parma, October 3, 2019 – CFT S.p.A. ("CFT" or the "company") announces the closing of the acquisition of a holding in the subsidiary Rolec Prozess- und Brautechnik GmbH, with registered office in Eichfeldstrasse 2, D-83339 Chieming (Germany) ("Rolec"), equal to 40% of Rolec's share capital. CFT, which already had a 60% stake in the company, now therefore wholly-owns the company.

Consideration of Euro 1.4 million was paid for the holding. The acquisition is part of a wider minorities acquisition plan, previously announced in the press release of September 30, 2019.

Rolec is a German company engaged in the design and sale of beer processing machines and equipment.

Alessandro Merusi, CEO of the CFT Group, stated "The acquisition of the minority stake in Rolec, while also fitting with our wider minorities reacquisition plan, optimises synergies at Group level and consolidates the Beverage market business platform, combining the process technologies of Rolec with the Packaging technologies of CFT and Comac. A new Managing Director with extensive Beverage sector experience was appointed who will have the task of guiding Rolec to achieve the challenging objectives set for the coming years".
