Since the start of the programme, WIIT has bought N° 42,668 ordinary shares (equal to 1.61% of the share capital), for a total value of EUR 2,418,504.99.

Following the purchases made so far, WIIT holds a total of N° 107,428 own shares, equal to approximately 4.05% of the share capital.

The purchases have been carried out pursuant to the provisions of Art. 144-bis of Consob Issuers Regulation no. 11971/99, on regulated markets in accordance with trading methods laid down in market rules, in order to not allow for the direct pairing of buying and selling bids.
