Reggio Emilia, October 30, 2019 – Pursuant to Article 85-bis, paragraph 1, of Consob Regulation no. 11971 of 14 May 1999 (“**Consob Regulation**”), Newlat Food S.p.A. (“**Newlat**” or the “**Company**”) announces the composition of its share capital (fully subscribed and paid in).

The composition of the share capital described below derives from the execution of the share capital increase resolved on July 8, 2019 by the Shareholders’ meeting of the Company, for the purpose of the offer of Newlat ordinary shares to qualified institutional buyers aimed to the admission on the Mercato Telematico Azionario, organized and managed by Borsa Italiana S.p.A., which took place on October 29, 2019

The declaration issued under Article 2444 of the Italian Civil Code, regarding the amount of the share capital, was filed with the Reggio Emilia Companies Register Office on October 29, 2019.
