### **UniCredit avvia un accelerated bookbuilding del totale delle azioni ordinarie detenute in Mediobanca**

In linea con la strategia di dismissione di partecipazioni non strategiche, UniCredit S.p.A. ("**UniCredit**"), annuncia oggi l'avvio di un'operazione di cessione di azioni ordinarie di Mediobanca – Banca di Credito Finanziario S.p.A. ("**Mediobanca**" o la "**Società**"), per un quantitativo pari a ca. 8,4 per cento del capitale sociale della Società, equivalente all'intera partecipazione detenuta da UniCredit nella Società ("**Offerta**"). L'Offerta sarà realizzata attraverso una procedura di *accelerated bookbuilding* rivolta a determinati investitori istituzionali.

Il bookbuilding avrà inizio immediatamente. UniCredit si riserva il diritto di variare i termini e i tempi dell'Offerta in qualsiasi momento.

Per tale operazione, UniCredit si avvale di BofA Securities, Morgan Stanley e UniCredit Corporate & Investment Banking in qualità di Joint Bookrunners per l'Offerta. Nell'ambito del mandato conferito ai predetti istituti, UniCredit ha richiesto di procedere ad un collocamento diversificato agli investitori, impegnandosi a non interferire con l'allocazione delle azioni.

UniCredit è impegnata a supportare la crescita economica dei mercati in cui opera. I proventi della cessione saranno utilizzati per supportare lo sviluppo delle attività dei clienti di UniCredit.
