19 NOVEMBER IN MILAN**

**Milan, 18 November 2019** – Openjobmetis S.p.A. (Borsa Italiana: OJM), one of the leading Employment Agencies, listed on the Stock Market - STAR segment - managed by Borsa Italiana, will take part in the “Mid & Small in Milan” on November 19. In the same year, it acquired 70% of HC Srl, an educational company which implements initiatives dedicated to personnel development and motivation.
