INFORMATION RELATED TO THE IMPLEMENTATION OF THE SHARE BUY-BACK PROGRAMME (PERIOD 18TH NOVEMBER – 22ND NOVEMBER 2019)

Biadene di Montebelluna, November 25, 2019 – Geox S.p.A (“**Geox**”) announces to have completed the buy-back programme, announced on June 4, 2019 and launched on June 5, 2019, for a total maximum of 3,996,250 ordinary shares (equal to 1.54% of the current share capital) servicing 2019-2021 Stock Grant Plan in accordance with the resolution passed by the Shareholders’ Meeting on April 16, 2019.

Geox S.p.A. (“**Geox**”) also informs – according to the provisions of the (EU) Regulation no. 596/2014 and the (EU) Delegated Regulation no. 1052/2016 - to have acquired (in the period from 18th November 2019 to 22nd November 2019) 385,045 ordinary shares (corresponding to 0.15% of the total number of ordinary shares) at a weighted average price of Euro 1.1959 for a total counter-value of Euro 460,486.96.

Purchases have been carried out by Goldman Sachs International and on the basis of the information provided by Goldman Sachs International itself, here below is a summary of the daily transactions on Geox shares (ISIN CODE IT0003697080), in aggregate form:
