### Own shares purchases

Milan 02th December 2019 – WIIT S.p.A. Below, based on the information provided by the intermediary in charge of carry out the purchases, details of the transactions for the purchase of WIIT ordinary shares (ISIN IT0004922826) on the MTA regulated market are given on a daily basis:

Since the start of the programme, WIIT has bought N° 63,878 ordinary shares (equal to 2.41% of the share capital), for a total value of EUR 4,088,005.59.

Following the purchases made so far, WIIT holds a total of N° 128,638 own shares, equal to approximately 4.85% of the share capital.

The purchases have been carried out pursuant to the provisions of Art. 144-bis of Consob Issuers Regulation no. 11971/99, on regulated markets in accordance with trading methods laid down in market rules, in order to not allow for the direct pairing of buying and selling bids.
