(“DHH”) (DHH.MI | WDHH21.MI) (ISIN shares IT0005203622 | ISIN warrants IT0005203689), the cloud computing provider of Southeast Europe, announces that today DHH.si (DHH Slovenia) completed the acquisition of Si-Shell ([www.si-shell.net](http://www.si-shell.net)), the business unit of iServer d.o.o. - one of the most important Slovenian providers - focused on the hosting and domain segment and having approximately 1.800 active customers. The acquisition is aimed at consolidating DHH presence in the local market. This deal doesn't exceed 25% in any of the class tests (ref. Rules for Companies, art. 12), is not a substantial transaction, but has a strategic value for DHH since it increases the market share of the group in Slovenia.
