Digital Magics S.p.A., *business incubator* listed on the AIM Italia market of the Italian Stock Exchange (symbol: DM), hereby declares, according to article 17 of the AIM Italia Rules for Companies, the new breakdown of the share capital (fully subscribed and paid up) following the end of Third Exercise Period (from October 1 and up to October 31 2019) of the "Digital Magics SpA Warrants 2017-2022", ISIN code no. IT0005253247.

During the Third Exercise Period no. 62 warrants were exercised and no. 62 Digital Magics newly issued ordinary shares (the "Conversion Shares") were consequently subscribed (in the ratio of no. 1 new share for each Warrant exercised) at a price of EUR 6.95 each, for a total value of EUR 430.90.
