### **ASCOPIAVE: Report on the purchase of treasury shares**

Ascopiave announces today that the Company purchased on the automated share market, pursuant to the resolution passed at the Shareholders' Meeting held on 23rd April 2019, in the period between 13.12.2019 and 17.12.2019 no. 52,856 ordinary shares at an average price of Euro 3.9263 per share, for a total of Euro 207,531.02.

On the basis of information provided by the intermediary appointed for the repurchase of the shares, the details of the purchases of treasury shares on the MTA (Mercato Telematico Azionario) on a daily basis are reported below:

Following these operations, Ascopiave now directly holds a total of no. 10,508,881 treasury shares, equal to 4.483% of the share capital.
