**SUSPENSION OF THE EXERCISE
REGARDING THE “MARKET WARRANT AQUAFIL S.P.A.”**

Arco (TN), February 3, 2020 – Aquafil S.p.A. [ECNL IM] announces that, pursuant to Article 3.6 of the Rules for the “Market Warrant Aquafil S.p.A.”, the arithmetic average of the weighted average price of all ordinary Aquafil shares (ISIN IT0005241192) traded on the MTA market on a daily basis in January 2020 (as announced by the calculation agent BNP PARIBAS Securities Services) is € 6.3526, below the Strike Price, equal to € 9.5.

Accordingly, the exercise ratio for the conversion of the Market Warrant Aquafil S.p.A. warrants for February 2020 is negative, thus, pursuant to Article 3.1 of the Rules for the “Market Warrant Aquafil S.p.A.”, the Warrants are not exercisable during February 2020.

The Warrant owners are hereby informed that, in case the Average Monthly Price of Aquafil ordinary shares referring to the month of February 2020 exceed the strike price, the Warrants will be exercisable in the month of March 2020 on the basis of the exercise ratio that will be communicated to the public under the terms of the Rules of “Market Warrant Aquafil S.p.A.”.
