COMMUNICATION ON TOTAL AMOUNT OF VOTING RIGHTS

Saluggia, February 7th, 2020 – DiaSorin S.p.A. (“**DiaSorin**” or the “**Company**”) hereby announces that today, following the application submitted in accordance with Article 9-bis of the Company By-Laws by two shareholders, each of them holding a number of voting rights lower than 3% of the total amount of voting rights – having fulfilled the requirements and conditions under the applicable regulation and the Company By-Laws – no. 19,084 ordinary shares of the Company obtained assignment of increased voting rights (based on the ratio of two votes for each share).
