### PURCHASE OF THE MINORITY STAKE IN ABC ASSICURA FROM BANCA POPOLARE DI VICENZA IN RECEIVERSHIP

Verona, 20 February 2020. Today Cattolica Assicurazioni purchased a 40% stake in ABC Assicura S.p.A.<sup>1</sup> from Banca Popolare di Vicenza in receivership.

Following the acquisition, Cattolica Assicurazioni now holds 100% of ABC Assicura's share capital.

The transaction fits into the broader context of rationalisation and simplification of the Cattolica Group and it doesn't materially affect the Group's solvency position.

*Cattolica Assicurazioni is one of the main players on the Italian insurance market and the only cooperative company in its industry to be listed on the Milan Stock Exchange, where it has been present since November 2000.
