## UPDATED FINANCIAL CALENDAR FOR 2020

**Roma, March 6, 2020** – In compliance with existing regulation, the doValue Board of Directors reports the financial calendar for 2020, with an update concerning the approval of the Annual Report as of 31 December 2019, which will take place on March 20<sup>th</sup> 2020 and not on March 13<sup>th</sup> 2020, as previously communicated.

The updated financial calendar is as follows:

- March 20, 2020: approval of the Annual Report as of 31 December 2019; no significant differences are expected as compared with the preliminary 2019 results disclosed to the market on February 13, 2020;
- April 22, 2020: Shareholders' Meeting to approve the consolidated and statutory financial statements as of 31 December 2019;
- May 12, 2020: approval of the Interim Report as of 31 March 2020;
- August 4, 2020: approval of the Semiannual Report as of 30 June 2020;
- November 5, 2020: approval of the Interim Report as of 30 September 2020.

Conference calls with investors and financial analysts will be held after the Board of Directors meetings scheduled for May, August and November. In case of any change to the above mentioned dates the markets will be informed immediately.
