INFORMATION ON THE TOTAL NUMBER OF VOTING RIGHTS

Reggio Emilia, 8 April 2020 – Pursuant to art. 85-*bis*, paragraph 4-*bis* of Consob Regulation no. 11971 of 14th May 1999 (the "**Issuers Regulation**"), Newlat Food S.p.A. ("**Newlat**" or the "**Company**") announces that, on 1st April 2020, the shareholder Newlat Group S.A. lost increased voting rights to 1,000,000 ordinary shares of the Company, pursuant to art. 127-*quinquies*, paragraph 3 of Legislative Decree no. 58 of 24 February 1998 (the "**TUF**") and art. 6, paragraph 14) of the Articles of Association.

The aforementioned loss of the increased voting rights results from the sale by Newlat Group S.A. of n. 2,157,707 ordinary Newlat shares (of which 1,000,000 Newlat shares with increased voting rights) completed on 1st April 2020.
