Update on the activities of the CAREL Group production plants located in Italy

Brugine, 16 April 2020 - Following the latest regulatory measures implemented by the Government and in particular the partial expansion of the list of ATECO codes indicated in the annex to the Decree (DPCM) signed by Prime Minister on 10 April 2020, the CAREL Group announces that as of yesterday, 15 April 2020, a significant part of the production activity of the plant located in Brugine (PD) has resumed, in particular that relating to electronics which also includes both programmable and parametric controls.

This restart is accompanied by the reactivation of production linked to the essential chains (Food cold-chain, Healthcare and Data centres) which, again in the same plant, had taken place on 7 April, (following a specific communication to the Prefect).

It is recalled that the plant of the subsidiary Recuperator S.p.A. (based in Rescaldina - Milan and active in the production of heat exchangers) is currently in operation, albeit at a reduced capacity, for that part of production linked to the essential supply chains as defined by the Government.

Finally, in partial mitigation of the effects of the so-called "Lock-down" implemented in Italy, the Group confirms the full operation of its plants located abroad, in particular in the United States, Brazil, Germany, Croatia and China. The production capacity of the plants located in the latter two Countries has recently been increased also in order to compensate, as far as possible, for the lack of Italian production.

The initiatives already taken in relation to white-collar workers in Italy remain valid, enabling smart-working for a percentage close to 100%.

CAREL confirms its focus on the management of this emergency and has and will put in place all the necessary measures in order to better protect the health of its employees both in Italy and abroad.
