Reggio Emilia, 21 April 2020 – With reference to the mandatory public tender offer announced by Newlat Food S.p.A. ("Newlat Food") on 1<sup>st</sup> April 2020, pursuant to and for the purposes of articles 102 and 106, paragraphs 1 and 2-bis, of Legislative Decree no. 58 of 1998 (the "TUF") and concerning all the ordinary shares of Centrale del Latte d'Italia S.p.A., less the ordinary shares already held by Newlat Food (the "Offer").

Considering the extension until 15<sup>th</sup> May 2020 of the suspension *ex lege* of the administrative proceedings already pending on 23<sup>rd</sup> February 2020, or which started after that date, of the public authorities (including CONSOB), pursuant to art. 37 of the decree dated 8<sup>th</sup> April 2020 n. 23 linked to the "COVID-19" health emergency, Newlat Food announces that, during the first days of June 2020, it will file, with CONSOB, the offer document relating to the Offer and, in any case, in compliance with the law and that will be effective after the termination of the related suspension.
