DEM/ 9017893 of 26 February 2009, also evaluated that among the shareholders who submitted the so-called "*Minority List*" for the election of the Board of Directors – identified above as List no. 2 – and the controlling shareholder Ministry of the Economy and Finance (MEF), there are, to the Bank's knowledge, no relationships to be deemed decisive for the existence of relationship connections under the aforementioned legislation.
