San Giovanni in Marignano, 25 May 2020 – Aeffe SpA announces to have acquired in the period from 18 May 2020 to 22 May 2020 included, in conforming with the programme released to the market on 30 July 2019 and approved by the Shareholders' meeting held on April 18, 2019, a total number of 70,000 treasury shares (corresponding to 0.07% of the total number of the ordinary shares), at weight average price of Euro 0.9038 for a total countervalue of Euro 63.266.00.

The Company, listed on the STAR segment of Borsa Italiana, operates in the luxury sector, with a presence in the prêt-à-porter, footwear and leather goods division under renowned brand names such as Alberta Ferretti, Philosophy di Lorenzo Serafini, Moschino and Pollini.
