FILING OF OFFER DOCUMENT WITH CONSOB

Reggio Emilia, 3 June 2020 - Newlat Food S.p.A. (the "**Offeror**") announces that it filed today with Consob - pursuant to and for the purposes of article 102, paragraph 3, of Legislative Decree no. 58 of 1998 (the "**TUF**") and article 37-ter of the Regulation adopted with Consob resolution no. 11971 of 14 May 1999 (the "**Issuers Regulation**") - the offer document (the "**Offer Document**") relating to the mandatory public purchase and exchange offer (the "**Offer**") launched by the Offeror on all the ordinary shares of Centrale del Latte d'Italia S.p.A. ("**CLI**"), after deducting the shares already held by the Offeror at today's date, and, therefore, on a maximum of 7,339,778 ordinary shares issued by CLI and listed on the STAR Segment of the Mercato Telematico Azionario organized and managed by Borsa Italiana S.p.A. (the "**CLI Shares**").

It should be noted that the Offeror will give a consideration for each tendered CLI Share consisting of:

- (i) a component consisting of Newlat Food ordinary shares, equal to n. 0.33 newly issued Newlat ordinary shares (the "**Newlat Food Shares**"), resulting from the share capital increase that will be submitted for approval by the Offeror's Shareholders' Meeting called for June 25, 2020; and
- (ii) a cash component, equal to € 1.00.

At the same time as the Offer Document was filed, the Offeror deposited with Consob the Prospectus (in tripartite form) relating to the public offering of the Newlat Food Shares.

The Offer Document will be published upon completion of the preliminary proceedings carried out by Consob pursuant to article 102, paragraph 4, of the TUF.
