**ANNOUNCEMENT OF CHANGE IN VOTING RIGHTS FOLLOWING THE INCREASE IN VOTING RIGHTS RELATED TO NR. 900,000 SHARES OWNED BY THE SHAREHOLDER HERMES LINDER FUND SICAV PLC (pursuant to art. 85-bis of the Issuers' Regulation)**

*Milan, 5 June 2020* – Openjobmetis S.p.A. (Borsa Italiana: **OJM**), one of the leading Employment Agencies, listed on the STAR segment of the MTA market operated by Borsa Italiana, announces the entry into force of the increased voting rights related to 900,000 shares owned by the shareholder HERMES LINDER FUND SICAV PLC.

Note that, as a result of the above, the voting rights of the shareholder HERMES LINDER FUND SICAV PLC increased from 952,296 to 1,852,296.
