## Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 7 May 2019 and 4 May 2020, and launched on 28 January 2020, Sabaf S.p.A. informs that in the period between 1 June 2020 and 5 June 2020 acquired no. 10,321 treasury shares at an average unit price of € 10.9292 per share, for a total amount of € 112,800.60.
