## Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 7 May 2019 and 4 May 2020, and launched on 28 January 2020, Sabaf S.p.A. informs that in the period between 7 September 2020 and 11 September 2020 acquired no. 3,546 treasury shares at an average unit price of € 11.9417 per share, for a total amount of € 42,345.25.
