The Board of Directors then named Alberto Gargioni as the Group's Chief Financial Officer.

Alberto Gargioni has gained significant professional experience at Italian and international financial institutions, among them Santander, serving as Head of M&A for continental Europe. Leonardo & Co., as Managing Director, Lazard, as Director, and KPMG.

With a business degree from Bocconi University, he earned an MBA at the Politecnico di Milano's School of Management. Since 2019, he has been the CFO of Nuova Argo Finanziaria, 60% held by Aurelia (in the Gavio family) and 40% held by Ardian.

With his experience in international investment banks and institutions, as well as in managing complex cross-border financial transactions, Mr. Gargioni's appointment is another step on the road to strengthening the Group's central corporate structure and its strategic growth and internationalization in the years to come.
