APPOINTMENT BY CO-OPTION OF THE INDEPENDENT BOARD DIRECTOR MARIA CRISTINA ZOPPO

Reggio Emilia, 25 September 2020 – The Board of Directors of Newlat Food S.p.A. ("**Newlat Food**" or the "**Company**"), which met today under the chairmanship of Angelo Mastrolia, appointed by co-option, pursuant to art. 15 of the current Articles of Association, Maria Cristina Zoppo, born in Turin on 14 November 1971, as a non-executive and independent director, following the resignation of Emanuela Paola Banfi, last 14 September.
