### Own shares purchases

Milan 5<sup>th</sup> October 2020 – WIIT S.p.A. Since the start of the programme, WIIT has bought N° 12,620 ordinary shares (equal to 0.48% of the share capital), for a total value of EUR 1,961,679.99.

Following the purchases made so far, WIIT holds a total of N° 136,326 own shares, equal to approximately 5.14% of the share capital.

The purchases have been carried out pursuant to the provisions of Art. 144-bis of Consob Issuers Regulation no. 11971/99, on regulated markets in accordance with trading methods laid down in market rules, in order to not allow for the direct pairing of buying and selling bids.
