Reggio Emilia, 4 November 2020 – With reference to the news published on the MergerMarket website, the company Newlat Food S.p.A. ("**Newlat Food**" or the "**Company**") confirms to have communicated to the shareholders of the Hovis Holdings Limited group ("**Hovis**" or "**Target**") that it does not intend to proceed further in a competitive tender for the purchase of Hovis.

Newlat Food, while confirming its interest in the acquisition of the Target, informed the counterparty that the negotiation will be resumed only in the event that the shareholders of Hovis grant, on the basis of the non-binding offer, an exclusive negotiation period to Newlat Food in order to be able to proceed quickly to the closing of an agreement.

As soon as the Company receives a reply to the request for exclusivity or any other detail regarding the transaction, it will promptly notify the market.
